According to experts, one in four children has a vision problem and, of those, ninety percent do not wear glasses. Children who cannot see well have difficulties reading and learning which often results in consequences for

When children can't see the white board during class, they disengage from learning and are more likely to drop out of school and get into trouble. It is estimated that ninety percent of low literate adults have vision problems as well. One cannot help

## **GED® Next Generation Update**

mean for literacy providers? How will students' needs change once the new test comes out? How can we begin to prepare now?

These were some of the questions we asked of Ann Beeson, sales consultant and founder of Adult Education Specialists, at our community training event on January 17th.

The GED® Next Generation is scheduled to be launched sometime in 2014. The new test will be designed to assess the Common Core State Standards and therefore will be more rigorous then the current assessment which is based on 1999 curriculum standards. It will consist of four parts: literacy, mathematics, science, and social studies and is suspected to no longer include the traditional five-paragraph essay. Instead several extended response questions will be integrated into the four sections. Additionally, the test will be administered only via Computer Based Testing (CBT).

Why are these changes occurring? Pearson VUE and the American Council on Education are joining forces to create the updated GED® test. Once a non-profit entity, the new GED® is now a for-profit enterprise. It is estimated that by 2018, 63% of all jobs will require some college or better (Center on Education and the Workforce, 2010). This does not bode well for the 39 million Americans currently without a high school diploma or the equivalent.

The Next Generation GED® differs from its predecessor is several ways. Interdisciplinary skills and higherorder thinking will be critical for the GED® Next Generation. Shift will be

We keep hearing that the GED will toward writing about reading, more be changing in the next couple years, varied reading passages, and a more but what do these changes really concentrated focus on non-fiction pieces. Writing prompts are expected be less introspective and more argumentative and informative. Additionally, the science and social studies sections will require more content knowledge as well as reading comprehension.

> In summation, the test will be changing, the standard will be raised, and it will fall on Adult Educators to bring our students up to the new level. As daunting as this task may seem, the reality is that this new level will ultimately help our students succeed in community colleges, tech schools, and in the workforce. Let us continue climbing the mountain one step at a time and always remember it is ultimately for our students.



The demand is expected to increase for the current exam as we move closer to the new GED® release date. Do not to delay in having your capable students register for the test since testing centers will be filling up quickly. And be sure to check out the free <u>keyboarding program</u> that Ann recommended to help your students become comfortable with using computers.
